RULES

- ❖ The Tournament serves as a Selection Event for Indian passport holders and Karnataka Residents.
- ❖ AICF Registration: Only players who have completed their AICF Registration for the financial year 2018-19 are eligible to participate.
- ❖ UKCA Registration : UKCA membership is compulsory for all the players to participate in this Event. Players will have two options provided in connection with the UKCA fees:
 - 1) To be exempted from paying the UKCA fee of Rs 50 for every tournament, players may opt for the one time UKCA membership fee of Rs 1000/ -. The UKCA registration form may be downloaded from www.karnatakachess.com
 - 2) Players may choose to pay the UKCA registration fee of ₹ 50/ - if they do not wish to become a UKCA Member.
- ❖ The tournament will be played on Swiss league basis under latest FIDE rules .
- ❖ Latest FIDE TIE break rules will be applicable in case of a tie.
- ❖ Prizes will not be shared.
- ❖ Time Control: 90 minutes plus 30 sec increment.
- ❖ Default time : 15 minutes (or as decided in the Players Meeting)
- ❖ Protest if any, shall be lodged in writing with protest fee of ₹ 1000 within 15 minutes of the

- ❖ Organizer has the right to accept or reject any entry without assigning any reason.
 - ❖ The top 4 players would be selected to represent Karnataka in National Challengers. Their entry fee will be borne by Akshayakalpa.
 - ❖ It is compulsory to attend the prize Distribution function. Else, the prizes/certificates would not be provided.
 - ❖ Players are required to bring their own water bottles – we will be providing drinking water and avoiding using plastic/paper cups to protect our environment.
 - ❖ Players and accompanying persons are required to arrange for their own food and accommodation during the entire duration of the tournament.
